1: Climate Protection - From Paris to G-20

The G20 countries are not only responsible for over 75% of global emissions, many of them also possess the financial resources and technologies needed to support other countries in their response to climate change. While last year's G7 summit produced some positive outcomes on climate - particularly the commitment to decarbonization and specific initiatives to support poor countries - the G20 outcomes remained vague. Yet, action by the G20 will be crucial to turn the objectives of the Paris Agreement into reality. The current Chinese presidency of the G20 has already announced a focus on 'areen finance' and the German presidency in 2017 might be interested in pursuing the decarbonization agenda further. This session will bring together experts from some G20 countries to discuss: What are the most important outcomes the G20 countries need to commit to? How can we ensure that past commitments of the G7 and G20 are implemented? How can the voices of vulnerable people and civil society be heard more strongly at the G20? English

5: A coal consensus for Germany and North Rhine-Westphalia

After Paris the next step in national climate policy is to define the pathway to Germany's long term goal of reducing CO2 emissions by 95% by 2050 and to achieve decarbonization. For this to be realistically achievable, complete coal phase-out in Germany has to be achieved by 2035, latest 2040. One of the main coal regions in Europe - North Rhine-Westphalia - must start to take a lead. How to manage the transition and what local stories have global relevance? German
